The scholarships will be awarded to students who graduate from a York County high school in this current school year (2018/19), is a credit union member by date of application, and plans to attend an institution of higher learning (accredited two or four year degree program) in the fall of 2019.

Applications will not be accepted for those enrolled as part-time students or for those taking adult remedial education courses.

0- 5 points	Letters of Reference
<u>0- 5 points</u>	Membership Tenure

To complement our program, this year's essay topic is: **Why is philanthropy important in today's world? And, why is it important to you?** *(Please submit a TYPED essay 500 to 1,000 words in length.)*
7. Submit your completed application along with the above requested items by April 5, 2019. **All requested information must be included. Incomplete or late applications will be disqualified.**
