All entrants must be a member of First Capital Federal Credit Union and be at least 18 years old. Charged-off accounts are ineligible to win. First Capital Federal Credit Union employees, Board of Directors, and Supervisory Board are not eligible to win.

First Capital Federal Credit Union members have the chance to participate in the First Capital FCU 65th Anniversary Giveaway Promotion for the opportunity to win a \$65 Dollar Gift Card during the eligible promotion period. A transaction can be a physical transaction or digital transaction done by a member at a branch, over the phone, or online. A transaction is defined as a deposit; withdrawal; product purchase; loan payment; new loan; debit card deposit; withdrawal, or purchase; transfer; bill pay. PRIZE
